Associate Membership - On the Contact List - Intermediate Dry Sail

- This is for new member to the club that wants to dry sail a small boat with a pathway forward to Active Membership with wet well privileges.
- You want to keep a small boat at the club, your name goes on the Contact List and when it approaches the top you will be offered Active Membership with wet well privileges.
- For additional information you should reference club policies A016 Contact List and A017 Intermediate Dry Sail. This information is available on the club's website sarniyachtclub.ca
- You are entitled to limited boating privileges. - See Policy A017
- After six years as an Intermediate Dry Sail Member, you are required to take out Active Membership or your membership status reverts to Associate Social
- The initiation fee is payable in a lump sum or over a six year period.

These are some rules that apply:

1. All children 8 years of age or younger must wear an approved personal flotation device (PFD) at all times while on SYC property. The following exceptions apply when under direct supervision: a) While inside a building or b) While in the playground area. PFD's must be removed on the Playground Equipment.
2. The posted speed limit for vehicles must be obeyed.
3. Summer weekend parking inside the Club is limited to members only - please ask your guests to park on Fort St. (Exception for clubhouse rentals). Members' cars shall display the SYC crest and the current year sticker.
4. Members must not park their vehicles in designated "no-parking" areas, including the dry-sail storage areas.
5. Members, family and guests must behave in a manner that shows consideration for the right of other members to the enjoyment of our Club.
6. Pets must be controlled on a leash and be attended by the owner at all times. Owners must clean up after their pet.
7. Smoking is not permitted in or around SYC buildings.
8. Quiet time is from 11:00 p.m. to 8:00 a.m.
9. Swimming around docks, off seawalls or in the entrance channel is prohibited.

The roster is printed once a year and contains a complete set of the rules. You should make yourself familiar with them. You can view all rules and policies on line at sarniyachtclub.ca
